Current Situation

- FCPF Readiness process is led by the countries
 - Strong emphasis on capacity building!
- Cameroon, DRC, Gabon and Republic of Congo have been selected
- These four countries have immediate access to \$200,000 to prepare a Readiness Plan (R-Plan)
 - R-Plan offers the possibility of coordination of initiatives in a country and possibly at the regional level
- Upon approval of the R-Plans by the Participants Committee, countries will access additional funding (up to \$3.5 million) to implement R-Plans
 - Republic of Congo: additional funding is contingent upon additional funding to the FCPF Readiness Fund



Final Country Selection

Other Congo Basin countries may participate in the FCPF Readiness Mechanism

- New selection round in March 2009
- Deadline for R-PIN (re)submission:
 December 15, 2008
- 5 more countries to be selected worldwide (25 + 5 = 30)
- Assume that one could be from the Congo Basin



R-Plan: Major Components

2- Management of the Readiness Process	a. Description of the national REDD working group and its work plan
	b. A detailed Consultation and Outreach Plan for the Readiness Process
3- REDD Strategy Design	 ToRs for the design of a national REDD Strategy(ies), including: Assessment of candidate activities for a REDD Strategy (building on component 1); Evaluation of potential additional benefits of REDD, including biodiversity conservation and rural livelihood; Assessment of trade-offs across candidate elements of your REDD strategy; Risk assessment of REDD strategy.
4- REDD Implementation Framework 5- Assessment of social and	Framework ToRs for the design of a national REDD Implementation framework
environmental impacts of candidate REDD strategy activities	Summary of proposed impacts analysis methodology and ToRs for carrying out the analysis
6- Assessment of Investment and Capacity Building Requirements	ToRs for carrying out the analysis of investment and capacity building requirements for REDD
7- Development of a reference scenario of deforestation and degradation:	Summary of work plan to develop a reference scenario and ToR for analysis.
8- Design of a monitoring, reporting and verification system for REDD	Summary of the work plan to design and implement a MRV system and ToR for implementation of work plan.



Regional Approach

Possible FCPF support for a regional approach to REDD in the Congo Basin:

- Regional approach is important to preserve ecological integrity of the Basin
- Countries receiving grants could support implementation of regional-level activities:
 - Setting forward-looking reference scenarios
 - Establishing a network of permanent plots for carbon assessment
 - Understanding drivers and agents of deforestation at the regional level
 - Strategic Environmental Assessment at the regional level
- Paper on regional approach prepared for FCPF meeting in March 2009 (AFD leading)
