In its response to climate change, Central Africa has attached great importance to REDD+. The humid forest areas of Central Africa, especially the Congo Basin, quickly emerged as the contribution of the region to global efforts to fight against climate change. Agriculture, logging and even mining are all sectors that have a nexus in one way or another to the preservation or modification of the forest. Moreover, in Central Africa, in addition to the wet forest areas, there are other ecosystems such as mangroves, lowlands, semi-arid and arid areas, etc. that need to be taken into consideration in national responses to climate change. Documents submitted or to be submitted to the UNFCCC should consider this ecosystem and sectoral diversity.

This insights market will be an opportunity to present preliminary information, initiate brainstorming and start discussions that can help provide greater impetus to go beyond what is being done on REDD+ in relation to various land use and forest use types in the region.
